

Diamond Dance Studio Competition Contract

I _____ parent/guardian of dancer _____ agrees to the following:

1. My dancer will commit to the full season of dance 2023-2024 from August 2023 to May 2024 at Diamond Dance Studio.
2. My dancer will participate in the necessary classes for the full season of dance 2023-23 from August 2023 to May 2024 at Diamond Dance Studio.
3. I have read through the competition handbook and understand all that is required of me as a parent/guardian and my dancer and will reference back to the handbook throughout the year.
4. I understand that there will be a \$35 late fee for monthly payments that are not paid by the 15th of each month.
5. I agree that my dancer will attend the scheduled competitions for the 2024 competitive season as a team member of Diamond Dance Studio's competition team. If my dancer misses any of the competitions, they will be cut from the team.
6. I agree to the payment schedule for all entry fees for competitions. Entry fees are per dance, per competition. I understand that if competition fees are not paid on time, there will be a \$35 late fee charged to the account and my dancer will be cut from the team.
7. I agree to the payment schedule of all costume fees incurred as a participant of the competitive dance team. I acknowledge that each routine my dancer competes will have a specific costume. I understand that if costume fees are not paid on time, there will be a \$35 late fee charged to the account.
8. I understand that all competition dancers will need accessories (necklace, hair pieces and earrings) with their costume for competition and I have reviewed the fees. A \$35 late fee will be charged to account if fee is not paid on time.
9. I acknowledge that all competitive entry fees, costume fees and accessory fees are non-refundable. I acknowledge that there are no refunds of fees for classes for the duration of the contract.
10. I understand that the dress code is designed to ensure the safety of the dancers. It allows the staff to observe the technique and posture of the participants to ensure the movements are executed in an appropriate and safe manner. The dress code instills a sense of discipline and pride in our students and maintains their focus on dance. Dancers who do not follow the dress code will be talked to.
11. I agree to stay informed throughout the year. There are many resources for parents to help them stay informed. Please read all of your email, newsletters and policies and procedures.

12. I understand that the performance hair and makeup requirements will change year to year and it is the parents' responsibility to check the website for current hair and makeup requirements for performances.
13. I understand that instructors will eat during class times. Most nights the instructor is at the studio from 2:00-9:00 so eating is necessary.
14. I understand that the monthly tuition is not just for class times. The owner/instructors spend a lot of time outside of class time working. If classes are canceled, they will not be made up unless otherwise stated. Virtual classes will not be offered.
